Did you know that you can access almost all of the New York State Department of Health forms online at: www.health.ny.gov/environmental/water/drinking/forms/forms.htm

I have utilized their website for years to access .pdf versions of their Backflow Test report (DOH1013) and the Daily Operations Report in a variety of configurations based on your treatment process. Although not all forms can be found using the link above, most of your major forms and reports can be found somewhere on their website. To simplify navigation to all things related to Drinking Water go to: www.health.ny.gov

Scroll to the bottom of the *home page* and look for topics *A to Z* and click on that. There you will find an alphabetical listing of all the topics the New York State Department of Health deals with. *Choose D*, then scroll down to and click on *Drinking Water*, and you will find just about anything that a Water Operations Specialist or Consulting Engineer needs to know about Drinking Water in New York State.
